Some of these changes involve the internet and computer programs, and are taking place in the **digital world** (e.g. computer software and algorithms capable of performing ever-more-complex tasks with minimal human input). Other changes involve robotics and automation, and are taking place in the **physical world** (e.g. the use of drones, self-driving cars, or self-service machines, to perform specific jobs with minimal human input).

Those who made less than the threshold through employment earnings would be paid the difference by the federal government, while those who made more than the threshold would receive no additional

funding. This payment would typically replace most or all other forms of government assistance, such as welfare and employment insurance.
